Nigeria has a few policies and strategies in place to support digital transformation, digital innovation and entrepreneurship. While policies such as the Digital Economy Strategy (2020-2030) and the National Digital Innovation and Entrepreneurship Policy, which outline key delivery mechanisms, are in place, execution of key policies down to the state level is lagging.

Insights from diverse studies and stakeholder engagements reveal that a participatory policy implementation framework is essential for ensuring the effectiveness, accountability, empowerment, and sustainability of policies across diverse contexts.

This Participatory Policy Implementation Framework (PPIF) was developed by the National Information Technology Development Agency (NITDA), in collaboration with the GIZ/Digital Transformation Center (DTC) Nigeria. The framework will facilitate inclusive, transparent, and effective implementation of national policies and strategies at sub-national level. Rooted in the principles of stakeholder engagement and collaborative governance, it aims to bridge the gap between policy formulation and execution.

The framework was developed by actively involving diverse stakeholders, including state and non-state actors, the private sector, and local communities at both national and sub-national levels. A structured methodology that incorporates a review of existing frameworks and the adaptation of international best practices was applied.

The importance of the PPIF in ensuring inclusivity and collaboration in the implementation of policies presents immense benefits to people, businesses, and the country. These benefits include:

- Increased transparency and accountability in policy development and implementation process, building trust between government institutions and citizens
- Enhanced local relevance by integrating indigenous knowledge and local perspectives, ensuring policies are contextually relevant to the people they serve
- Enables policies to be more adaptable to changing circumstances
- Enhanced policy implementation and sustainability
- Empowerment of stakeholders, fostering a sense of ownership and responsibility
- Evidence-based decision making and policies for better outcomes

The PPIF was handed over to the Ministry of Communications and Digital Economy in July 2024, for upscaling at the Federal level. It will be implemented in pilot programs at the state level to promote socialisation and adoption.

# Introduction


By involving the relevant stakeholders, such as tech professionals, businesses, academics, civil society organisations, and the general public, participatory policies help create more effective,

# Methodology



### **Review of Existing Frameworks**

To build a robust PPIF, it is crucial to analyse existing frameworks that have been successfully implemented in similar contexts. The Nigeria Startup Act (NSA) and the National Digital Literacy Framework (NDLF) provide valuable insights and lessons for developing the PPIF.

## Nigeria Startup Act (NSA)

The Nigeria Startup Act was enacted to create an enabling environment for technology-enabled startups by fostering innovation, supporting entrepreneurship, and ensuring regulatory support. The Act was developed through extensive stakeholder engagement, involving startups, investors, civil society, and government agencies. This collaborative approach ensured that the Act addressed the needs of the tech ecosystem comprehensively<sup>1</sup>.







#### Fig 2:Key components of the Nigeria Startup Act

The NDLF is a strategic initiative designed to enhance digital literacy and skills across Nigeria with the goal of bridging the digital divide and promoting digital inclusion. Below are the key objectives of the NDLF:

### **Case Studies**

### **Brazil's Participatory Budgeting**

In cities like Porto Alegre, Brazil, participatory budgeting has been implemented to involve citizens directly in the decision-making process that regards the allocation of public funds. This approach allows residents to propose and vote on community projects, ensuring that public spending reflects the community's priorities and needs<sup>2</sup>.




Fig 4:Impacts of the Brazil's Participatory Budgeting

### Kenya's Open Government Partnership (OGP)

Kenya's OGP initiative is a collaborative effort to promote transparency, accountability and public participation in governance. Through the OGP, Kenya has committed to implementing reforms that enhance open government practices including access to information, public participation, and anti-corruption measures<sup>3</sup>.

# **Stakeholders Engaged**

# Key Insights

This approach is fundamental to creating inclusive, transparent, and effective policies that reflect the needs and aspirations of the community. By fostering stakeholder participation early in the policy cycle, governments and organisations can enhance policy legitimacy, foster trust, and ensure smoother implementation.

#### **Table 1: Importance of Participation and Inclusion**



### A. Enhanced Legitimacy:

Policies developed through participatory processes are more likely to be accepted and supported by the public. Inclusion of diverse stakeholders lends credibility and legitimacy to the policy. 6



### **B. Increased Transparency:**

Open and participatory policy development processes promote transparency, helping to reduce corruption and build public trust in governmental and organisational processes.





### **C. Better Outcomes:**

Involving stakeholders can lead to better-informed decisions and more effective policies as diverse perspectives and expertise are brought into the policy-making process.



### **D. Empowerment:**

Participation empowers stakeholders, particularly marginalised and vulnerable groups, giving them a voice in decisions that affect their lives while fostering a sense of ownership and responsibility.



### **E. Improved Implementation:**

Policies developed with stakeholder input are more likely to be successfully implemented, as stakeholders are more likely to support and comply with policies they helped shape.






Fig 7: Key principles of a PPIF

## Inclusivity

Ensure that all relevant stakeholders, including marginalised and vulnerable groups, have the opportunity to participate in the policy development and implementation process. This principle emphasises the importance of diversity and equity in stakeholder engagement.



Maintain open and clear communication throughout the policy process, providing stakeholders with access to information and updates on policy development and implementation. Transparency fosters trust and accountability.

### Collaboration

Foster a collaborative environment where stakeholders can work together, share knowledge, and co-create solutions. This principle underscores the value of partnership and collective problem-solving.

### Responsiveness



Design policies that are adaptable and responsive to stakeholder feedback and changing circumstances. This principle highlights the importance of flexibility and continuous improvement in policy implementation.

### **Evidence-Based**

Utilise data and evidence to inform policy decisions and measure the impact of policies. This principle ensures that policies are grounded in factual information and rigorous analysis, leading to more effective and sustainable outcomes.

### Empowerment

Empower stakeholders by building their capacity to participate effectively in the policy process. This includes providing training, resources, and support to ensure meaningful engagement and contribution.
