



# **Digital Transformation Center, Nigeria**

### The Project

The Digital Transformation Center Nigeria (DTC Nigeria) is co-funded by the European Union (EU) and the German Federal Ministry for Economic Cooperation and Development (BMZ) and implemented by *Deutsche Gesellschaft Fuer Internationale Zusammenarbeit (GIZ) Gmbh*. The project focuses primarily on digitalisation and entrepreneurship. It aims to improve the capacity of the Nigerian economy to utilise digital innovations for growth and improve the innovation ecosystem. The end goal is to strengthen Nigeria's ability to leverage digital innovation across sectors.

# The Challenge

Nigeria has strong digital potential and ambitious policy frameworks in place. Despite this, it ranked 118 out of 132 in the 2021 Global Innovation Index. There's a gap in support for scale-ups and MSMEs outside the tech sector. MSMEs form 96% of businesses but lack digital skills and access to tools. Unemployment remains high, contributing to poverty and unrest, especially among youth. Women face deeper barriers due to poor access, education, and gender inequality. Bridging these gaps is essential for inclusive, sustainable digital transformation.

# The Approach

The project follows a holistic approach to digitalising the economy. It works with all stakeholders, with a focus on women and youth, in the digital ecosystem to promote the supply of and demand for digital innovation. Innovation centers, public and private service providers and consultants are empowered to support MSMEs with their digitalisation efforts. The project supports the government in implementing its policies and strategies for digitalising the Nigerian economy. In doing so, it promotes the long-term provision of digitalisation services for MSMEs, and, at the same time, positively contributes to the country's economic growth.


